Assumption and acknowledgment of risks and release of liability agreement

In consideration of participating in any way in the End of the Line Ski School, tournaments, programs, events, clinics, demos of equipment, related events and activities (hereinafter collectively and singularly referred to as “the Event”), I _____, The undersigned, acknowledge, appreciate and agree to the following:

1. The risk of injury from the activities involved in the Event is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist; and,
2. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the event sponsors and organizers, its officials, members and co-participants, or others and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for the use of the rented equipment while participating in the Event. If however, I observe any unusual significant hazard during my presence or participation, I will bring such to the attention of the nearest official immediately, and
4. I will be responsible for the replacement at full retain value of any equipment borrowed or rented but not returned to End of the Line Ski School and I agree to return all borrowed or rental equipment by the agreed date in clean condition to avoid any additional charges; and
5. The undersigned grant to the Event organizers the right to make and use any photographs, television or motion pictures taken during the Event, and agree that the organizers have the right to control or prohibit advertising material used, worn, or displayed by a participant at the site during the Event; and
6. The Event organizers and director reserve the right to disqualify the participant at their discretion and to refuse to allow the participant to participate in the Event for any reason they deem just and proper; and
7. I, for myself, and on behalf of my heirs, personal representatives and next of kin, hereby release, hold harmless, protect, indemnify and forever discharge the sponsors and organizers of the Event, the land or site owner, lessor, lessees, public or governmental agency having jurisdiction thereof, and/or the site operator, and agency that may be assigned to cover the Event, their agents, servants, employees and all persons connected with the Event, from any and all rights, claims and demands of nature for any and all loss, damage or injury sustained by the participant of his or her equipment at any time during the Event or before or after the Event but in connection with it; and
8. The undersigned is of legal age and competent to enter into this agreement and/or the parent and/or guardian of the minor participant on whose behalf they sign, and hereby agrees to indemnify and hold harmless to the full extent described in paragraph (7) above, those organizations and individuals named or described therein from and against any claim or suit due to injury or damage to the person or property of said minor participant.

I have read all of the above, I understand it and agree to all terms and conditions and affirm all promises, representations and warranties made by me as a condition and consideration for the privilege of participation in the Event. I agree to be fully responsible for my conduct at the Event and/or for the conduct of the minor on whose behalf I sign.
