ALL WINTERIZED BOATS MUST BE PICKED UP BY DECEMBER 15TH OR WINTER STORAGE RATES WILL APPLY. NO BOAT WILL BE REMOVED FROM PREMISES AFTER THAT DATE UNLESS IT IS WITHIN THE TWO WEEK SERVICE PERIOD. ALL OUTSIDE STORAGE BOATS REQUIRE SHRINKWRAP AND WILL BE CHARGED ACCORDINGLY. IF THE INVOICE IS NOT PAID WITHIN 10 DAYS OF THE FINALIZATION AND CLOSING, A \$39.00 LATE FEE PER MONTH PLUS A 2% FINANCE CHARGE WILL BE BILLED ON ALL DELINQUENT ACCOUNTS. CUSTOMER AGREES TO PAY ATTORNEYS FEES, COLLECTION FEES AND COURT COSTS FOR MUNSON SKI & MARINE IF ACCOUNT GOES TO COLLECTIONS.
